## **ABSTRACT (FONT SIZE: 12, bold)**

The paper should start with an abstract of approximately 300 words, summarizing the objectives, contents, results, and conclusions.

## **KEYWORDS (FONT SIZE: 12, bold)**

The abstract must be followed by a maximum of six keywords related to the main topics of the paper.

## **1. SUBMISSION OF PAPER ( HEADING FONT SIZE: 12, bold)**

Your paper including figures, tables, and references should be written in **English**. Please prepare your manuscript according to the format and style presented in this document. Manuscripts must be submitted in (.doc) format through the Author Gateway system. You will need a login name and password to access the Author Gateway. To get an access, you may submit an abstract online through the conference web site at <http://www.mdp.eg.net> or you may send it by email to [mdpfecu@yahoo.com](mailto:mdpfecu@yahoo.com).

Each completed manuscript including the figures and tables should not exceed **15 A4 pages** in a single spaced text.

## **2. FORMAT AND TYPING INSTRUCTIONS (HEADING, FONT SIZE: 12, bold)**

Please use **A4 page size** (210 mm x 297 mm). On each page, leave margins as follows: 30 mm on left, 20 mm on right, 30 mm on top (50 mm for title page), and 20 mm on bottom sides. Type in single spacing. Start Paragraphs without indentation. Use double spacing between paragraphs. Headings should be capitals and bold. Subheadings should be small bold letters with initial capital letters for all the main words and placed flush to the left-hand margin. Sub-subheadings should be all small letters with a capital for the first letter of the first word. Leave double spacing above subheadings and sub-subheadings.

**3.1. Stress Strain Response**

**3.1.1. Strain hardening measurments**

**Fill pages as completely as possible.** However, avoid having the last line of a paragraph as the first line of a page. Instead, move the next two lines to the top of the next page. Also, avoid making the first line of a paragraph or a section/subsection heading as the last line of a page. **Article title, authors' names** should be treated as shown above.

When typing complicated mathematical text it is important to increase the space between text lines in order to prevent sub/super-script fonts overlapping one another and making your printed matter illegible. Equations should be numbered in parentheses flush to the right hand border of the frame, without dots leading to the numbers, and leaving a single line space clear above and below the equation.

For body text, please use **12 Point Times New Roman**.

### **2.1. Figures, Tables and Illustrations (Subheading, Font Size: 12, bold)**

When referred to **Figures and Tables** in the text, they should appear as **Fig. 1, Table 3**. Figure captions should appear below the figure in small letters and should be centered, as shown in the following:

**Fig. 4. Stress-strain curves.**

**Table headings** should appear centered above the table, using bold fonts with one line space between heading and previous text, and between heading and table, e.g.,

#### **Table 2. Chemical composition**

Original of illustrations should be carefully pasted at their proper location in the text. Suitable line thickness and the appropriate size of lettering are required to be clearly legible when the illustration is reduced to final size. Photographs (only in black and white) should be included when it is absolutely essential. They should be printed on glossy high contrast paper, cut to rectangular form removing margins and superfluous background and pasted in place.

## **REFERENCES**

All **references** within the text should be numbered consecutively, with the number in square brackets. When authors' names are mentioned in the text, up to two names can be stated; three or more authors should be shortened to the first name followed by et al: e.g. **previous results [6-13] indicate. El-Danaf, et al [14] derived. References** should be grouped together at the end of the paper, after the **Acknowledgment**, if any, in numerical order, last names first in capital Examples:

If the paper contains many symbols, a **nomenclature** must be included after the references, starting with letters in alphabetical order; uppercase followed by lowercase of the same letter.
